MATERIALS WARRANTY 50-YEAR NON-PRORATED LIMITED WARRANTY

Centurion[®] Products, Inc. warrants its products for a period of 50 years from the date of purchase according to the following. All products covered by this warranty will be remedied by Centurion[®] Products, Inc. by repair or replacement of faulty stone in accordance with the applicable terms and conditions of this warranty. Centurion[®] recommends its products to be installed on structures which conform to local building codes and strictly adhere to manufacturer's installation instructions.

This warranty covers only products manufactured by Centurion[®] Products, Inc. which are determined to be defective. This warranty does not include damages from faulty or improper installation, willful abuse, misuse, negligence or damage resulting from fire, lightning, earthquake or other Acts of God, settlement of the building, failure of the structure (including foundations and walls) surface discoloration due to air pollution, exposure to harmful chemicals, normal weathering of surface, efflorescence, oxidation, or other causes beyond the control of the manufacturer. Centurion[®] Products is not responsible for labor costs incurred in removal and replacement of defective products. Centurion[®] Products are not recommended for use on walkways or driveways and are not covered by warranty when used in these applications.

If you feel the Centurion[®] Stone Veneer is not free from manufacturing defects, write to the Customer Service Department of Centurion[®] Products, Inc. 50 Van Buren Street, Nashville, TN 37208, describing the claimed defect. Centurion[®] will reply within two weeks of receipt of your letter advising the necessary physical evidence it requires to support your claim. If Centurion[®] determines the material is defective in accordance with the terms of this warranty, Centurion[®] will repair or provide new material (at its option) to replace those which are determined to be defective. Due to the fact Centurion[®] Products, Inc. has no control of installation; this warranty applies to stone products only, not to installation cost. Centurion[®] reserves the right to refund the original purchase price in lieu of repair or replacement.

Centurion[®] reserves the right to discontinue and or make changes in any of its products. In the event the product covered by this warranty is not available, Centurion[®] shall have the right to substitute products that, in Centurions[®] sole discretion, is of equal quality or price.
